In pursuance to order no. 334-353/Pr.D&SJ/(East)/KKD/Delhi, dated 15.01.2022 passed by Ld. Principal District & Sessions Judge (East), Delhi, proceedings of the present matter are being conducted through VC.

Present Shri Naveen Panwar, ld. counsel for the applicant/accused through VC.
Shri Sukhbeer Singh, ld. Addl. PP for State through VC.

Reply to the present application has been filed by SI Vishal.
Perused.

Arguments heard on the application seeking regular bail moved for the applicant/ accused. Record also perused.

It is submitted by Ld. Counsel for the accused that applicant/ accused has been implicated falsely in the present matter and no such crime has been committed by him. It is also submitted that applicant/ accused is a young boy of 20 years only and earlier anticipatory bail of the applicant/ accused stood disposed of observing that Section 324 IPC has been altered in the present matter to Section 326 IPC. One of the contentions of ld. counsel is that no useful purpose will be served by keeping the accused further behind the bars. It is also submitted that applicant/accused is not required for the purposes of any further investigation. Ld. Counsel submitted that applicant/ accused is ready to abide with the term(s) and condition(s) while imposing bail and thus, prayed for regular bail to the applicant/ accused.

Ld. Addl. PP opposed the application stating that allegations in the present matter are serious in nature.

Rival submissions considered and record also perused.

There is no dispute to the fact that applicant/ accused is a boy of tender age of 20 years and is in custody since the day of his surrendering himself i.e. 18.12.2021. Admittedly, earlier, present case has been registered under Section 324/34 IPC. Applicant/ accused not required for the purposes of any investigation further.

In view of the overall circumstances, applicant/accused Rehan Khan, S/o Bilal Khan is ordered to be released on regular bail on furnishing personal bond in the sum of Rs.50,000/- with one surety of the like amount to the satisfaction of the Id. MM concerned/ Link MM/ Duty MM. The accused shall mark presence in the police station on every 2nd and last Saturday of the month till filing of the charge sheet. The accused shall also provide his active mobile number to the concerned court and IO as early as possible and within a period of two days from his release. The accused shall not switch off the said mobile phone.

A copy of this order be sent to Jail Suptd. for information and another copy of this order be also sent to court of Id. MM concerned.

At request, a copy of this order be also given dasti to Ld. counsel for the applicant/ accused.

With these observations, present application stands disposed of.
