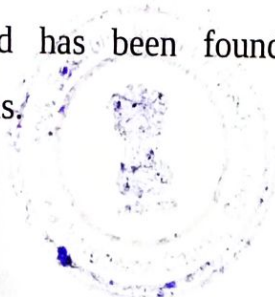
Pursuant to order no.569/RG/DHC dated 19.08.2021 issued by the Hon'ble High Court of Delhi, the proceedings in this matter have been conducted through video conferencing on Cisco Webex.

This is an application under section 439 of the Cr.P.C praying for grant of bail to the applicant/accused Vikas Chauhan for a period of 40 days to attend class practical examinations conducted by National Institute of Opening Schooling (NIOS). Reply to the bail application has been filed. Submissions have been addressed by the Counsel for the applicant/accused and the Ld. Addl. PP for the State with the assistance of the IO.

Sh. Aditya Aggarwal, Ld. Counsel for the applicant/accused has submitted that accused Vikas Chauhan is a student of class 12th and is registered with NIOS. Practical examinations for the subjects Biology, Physics and Chemistry are scheduled between 27.09.2021 to 07.10.2021. Some practical examinations for Biology are already over. It is submitted that education of accused will suffer if he is not permitted to attend and appear in the remaining practical examinations. Prayer is made to release the accused on interim bail for this purpose.

As per reply to the bail application filed by the IO, the registration and roll number of the applicant/accused Vikas Chauhan has been verified and has been found to be genuine including the scheduled examinations.





Keeping in view the fact that the examinations of the accused are scheduled and are going on, I hereby admit applicant/accused Vikas Chauhan on interim bail till 11.10.2021 to enable him to appear in the practical examinations conducted by the NIOS subject to him furnishing a Personal Bond in the sum of Rs.25,000/- with one surety of the like amount to the satisfaction of Ld.CMM / ACMM /MM / LinkMM /Duty MM.

The following additional conditions are imposed on the applicant / accused:-

- (1) Applicant shall disclose his mobile number to the IO and his phone shall not be switched off at any point of time during the period of interim bail;
- (2) Applicant / accused shall record his presence in PS Pandav Nagar on 02.10.2021 and 05.10.2021.
- (3) Applicant shall surrender before the concerned Jail Superintendent on completion of the interim bail period.

Bail application is disposed of accordingly. A copy of this order be sent to the jail Superintendent for information. Order dasti.
